Chairman's comments

As we embark on 2021, we can reflect on the highly unusual year gone and the things we would like to achieve in the year ahead.



Of course everything last year was permeated by Covid and the hugely impressive way the Parish pulled together to mitigate risk and support those most vulnerable. But over and above that, there were a lot of other things going on to protect and enhance the community we live in. Whether making real progress on the reduction in the speed limit through Crays Pond, resurfacing the Parish Hall car park, the improved and more environmentally friendly grass cutting specification, through to simpler little things like the enhanced telephone box libraries and bat boxes at Crays Pond, there was a genuine sense of progress. And over and above this, less visible but equally important, constant vigilance to ensure no inappropriate planning approvals and the protection of our many – and increasingly used - footpaths.

So we now focus on the coming year and look to shape our priorities. Probably our biggest mission is to maintain momentum on seeking wherever possible traffic speed reduction. We will keep an eye on ensuring that the new 30mph speed limit is implemented at Crays Pond as promised. We will also be seeking to influence Oxford County Council Highways Dept to reduce the speed limits through Whitchurch Hill, from the Coombe End crossroads, past the church and towards the hill itself – a challenging project based on previous experience. Over and above that, Parishioners have started to share their "wish-list" with us on improvements that they would ideally like to see happen. We of course do not have a bottomless pot of cash, and we have to ensure any public money is spent carefully and wisely, but funds and grants are available to make appropriate investments. At our Council meeting on 11th February we will agree our expenditure priorities for the financial year from April, so please feel free to share with us any thoughts that you have prior to that time.

In the interim, we look forward to navigating through the latest Covid related restrictions as safely as we can, welcoming the vaccination roll-out programme and hopefully regaining a sense of normality as the year progresses.

Goring Heath Parish Map





White Lion, Crays Pond

This won't be news to readers of the Henley Standard, but the appeal by the owner against the nomination of the White Lion as an Asset of Community Value (ACV) was unsuccessful, so the nomination stands. Although this is heartening for the supporters of the White Lion, there is still a long way to go. The status as an ACV simply means that the owner cannot sell the building without first offering it to the community, and there is a moratorium of six months between offering it for sale and selling it to someone else.

The original idea of the ACV process was probably aimed at large corporates, who before the legislation was introduced, were selling off places of importance to the community without any constraint. It's a different situation with the White Lion, as the owner is an individual with apparently different priorities from those that a corporate owner might have. The Community Group is considering the options for a way forward.

District Councillor's Comments

The Local Plan has now been adopted, and there has been some criticism of the members of the District Council who were elected last year, such as myself, who voiced opposition to the plan but, when it came to the crunch, did not vote against it. I, with others, abstained from voting. The reason was that the Secretary of State, Robert Jenrick, had the power to approve the plan if the Council did not adopt it. He had made it very clear that not only would he use that power, but that the planning function in South Oxfordshire would then be handed over to the County Council. With such a threat, there was no point in making a meaningless gesture and voting against adoption, but neither was there any purpose in voting to support a plan that I had objected to and which was going to be adopted anyway at that meeting.

Perhaps most readers eyes will have glazed over at this point, so I will say no more about it, as the worst aspects of this plan were about areas far from Goring Heath.

Other changes that are happening at the Council include the continued unwinding of the outsourcing contract with Capita, whose poor performance in many matters, for example preparation of the annual accounts, causes great difficulty.

One of the issues locally is the shortage of really affordable housing, and we have started examining the options of actually being a provider of low cost housing. This is a matter to be handled very carefully, and at the moment we are taking legal advice. Developers have to pay Community Infrastructure Levy (CIL) and contribute money called S106 when developments are built, and we do now have substantial amounts of these funds available, some of which could possibly be used for this purpose.

I am the Vice Chair of the Planning Committee, and major planning applications get referred to the Committee, as do minor application if objections are raised in a timely manner. All too often the decision is an inevitable, if unpalatable, one, because previous planning consent, Local Planning Policy or government policy makes the option of a refusal foolhardy, as an appeal will result in the same outcome, and costs being awarded against the Council. ...

However, there are occasions where the Planning Committee goes against officers' advice, and refuses an application, which when taken to appeal, is also refused by a Planning Inspector. When the decision reflects popular feeling, these results are a source of some satisfaction. It will be where the judgements on matters of design, impact on the area, effect on conservation areas or the countryside are subjective, and a reasonable matter of opinion.

The District Council is now actively involved in trying to control the effects of Covid-19 pandemic, taking on local track and trace when the national service has been unable to contact a local resident who has tested positive, so if you get a call from an 01865 number you don't recognise, it could be about Covid-19. We have also appointed Covid Compliance marshals who will be on duty in town centres and busy areas. They will engage, explain and encourage businesses and members of the public to adhere to Covid-19 guidelines to help keep everyone safe.

February 2021 Goring Heath NEWS BIRCHEN COPSE

Once again, our lives have become restricted, but we can still do one of the most rewarding activities available in our local area - walking our excellent network of footpaths.

Whilst the paths in our parish are extensive, and generally in good condition (apart from the mud!), there is always room for improvement. To this end, on behalf of the Parish Council, I have now submitted an application for the recognition of three new paths in Birchen Copse and the adjacent woodland.

These three paths are routes through the woods that have been used by local walkers over a very long time. One of them follows a track which was used in the mid 1850's, so this one can certainly claim historical significance as a forest routeway.

When the official map of the 'Rights of Way' was published some paths were not included even though they were in common use. These omissions can now be corrected by applying to have the path added to the official map.

But, as always, there is a snag! There is a cut-off date for applications of 2026, so there is some urgency in making these applications.

Do you have a favourite path which you walk regularly, and have done for many years, which does not seem to be an official path? These official paths are signposted, as footpaths or bridleways, and some, in the woods, have white arrows on the trees. The path you love could be blocked off at any time if it does not have legal status as a 'Right of Way'!

Please do get in contact with me if you are not sure about the status of a path you use, or if you think you know of a path which may be lost in the future without legal backing.

Do not, however, expect instant action. Oxfordshire County Council, who are the authority responsible for all the roads, including footpaths and bridleways, have a backlog of at least ten years in processing the applications. But..this is not a reason not to act now! ...

The footpath application in Birchen Copse was prompted by the fencing of some of the newly owned plots. The remaining plots have not been fenced, which is good news, and the Parish Council is still hoping that the enforcement actions of the team at S.O.D.C. will reduce the non-forestry activity in the woods.

South Oxfordshire District Council have had to temporarily delay the start of their garden waste service which was due to commence on 11 January due to reduced staffing levels, and to allow remaining staff to work on the core food and household waste collections.



They are monitoring the situation with a view to restarting this paid-for service as soon as possible.to ensure customers are not out of pocket.

They're not able to take on any new garden waste customers at this time, but this will be reviewed again when the situation changes.

Spotting Vaccine Fraud Alert

Throughout the pandemic, there have been a lot of scams circulating from people seeking to defraud or trick worried and vulnerable residents. **How to protect yourself:** At no point will anyone be asked to pay for the vaccine.

The NHS will never ask you for your bank account or card details. The NHS will never ask you for your PIN or banking password. The NHS will never arrive unannounced at your home to administer the vaccine. The NHS will never ask you to prove your identity by sending copies of personal documents such as your passport, driving licence, bills or pay slips.

What to do if you are targeted:

If someone receives a call, they believe to be fraudulent, they should hang up. If an email looks suspicious, do not click on any of the links - forward it to report@phishing.gov.uk.

Suspicious text messages should be forwarded to the number 7726 which is free of charge.

Anyone who believes they are a victim of a fraud, should report it immediately via actionfraud.police.uk or by calling 0300 123 2040.



If you need to travel to **Reading or Henley** by bus, here are a couple of local Going Forward Bus routes you could use:

Bus Route 145 (Goring to Reading via Whitchurch Hill and Crays Pond) which runs on Tuesdays only.

The bus journey starts in Goring, before travelling up to Whitchurch Hill, stopping outside The Sun Pub at 09.25. The next stop is Crays Pond Telephone Box at 09.29 followed by a stop at Goring Heath Almshouses at 09.32. The bus also stops at Cane End, then various points including Caversham Library, before arriving at Blagrave Street, Reading (behind Marks and Spencers) at 09.52. It then travels on to Tesco (Kings Meadow). It leaves Tesco at 11.20 arriving back in Crays Pond at 11.47 and Whitchurch Hill at 11.50.

Bus Route H1 (Crays Pond to Henley)

This route runs on **Thursdays** only until further notice.. Stopping at the Telephone Box in **Crays Pond** at 09.12, then at various points including Woodcote, Checkendon, Stoke Row, Peppard Common, Sonning Common and Rotherfield Greys before arriving at **Henley Market place** at 09.40 and **Henley Railway Station** (Request). It leaves Henley Market Place at 11:45, arriving at Crays Pond at 12.06

Bus pass holders travel for free, otherwise there is a flat fee of £4 each way—please put the correct money in to the red box. Sorry we cannot give change.

Social distancing must be observed and face coverings must be worn, otherwise you will not be allowed to travel.

The Parish Council would like to remind those with dogs of the Ordnance Survey Country Code for Dog Owners, in order to enable us all to enjoy the countryside and keep your dog safe.

- Ensure your dog is under effective control, which means you have a short lead
 with you and use it when needed (e.g. around livestock, near cliff edges or where
 signage requests it). You do not let your dog off the lead unless you keep it in
 sight and close enough to come back to you on command.
- 2. Prevent your dog from approaching horse riders, cyclists, or other people and their dogs uninvited.
- 3. Keep your dog with you on paths or access land and don't let it stray into crops including fields of grass, fruit and vegetables.
- 4. Never let your dog worry or chase wildlife or livestock.
- 5. Follow advice on local signs to reduce disturbance to plants and animals.
- 6. Stay SAFE around farm animals and horses: Stop, look and listen before entering a field; be aware of any animals present. Always keep your dog on a short lead. Find the safest route around animals, giving them plenty of space and using paths or access land where possible. Exit the area calmly and quickly if threatened, releasing your dog to make it easier for you both to reach safety. Always bag and bin your dog's poo wherever you are. You can use any public waste bin or your bin at home.
- 7. Never leave bags of dog poo lying around, even if you intend to pick them up later. Containers and deodorised bags can make them easier to carry.
- 8. Ensure your details are on your dog's collar and it is microchipped, so you can be reunited quickly if it is lost.
- 9. Keep your dog's vaccinations and worming up to date. Ask your vet for more information.
